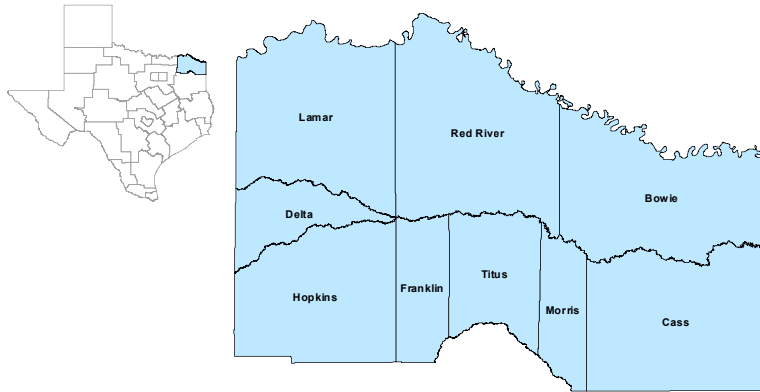

January 2025



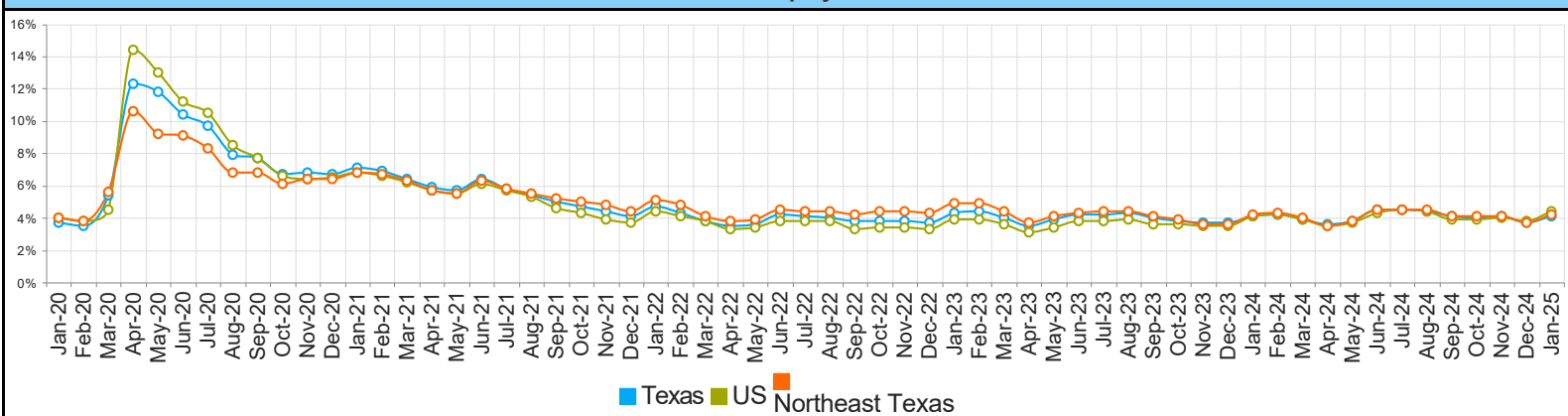

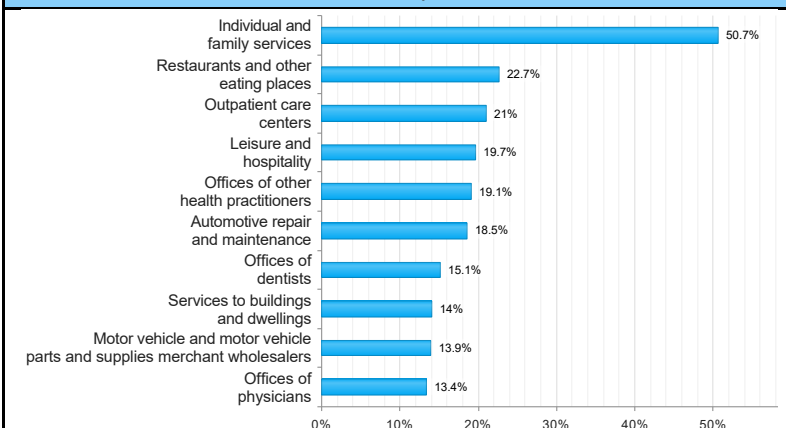

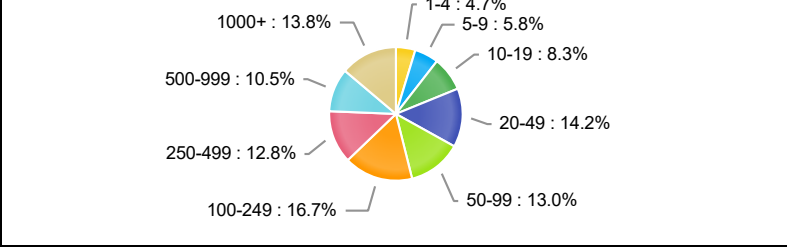
## Historical Unemployment Rates



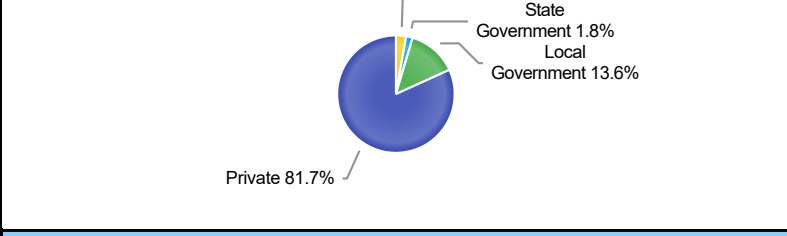
## Projected Top Ten Fastest Growing Industries in WDA (% Growth 2022-2032)

## Employment by Ownership (3rd Quarter 2024)

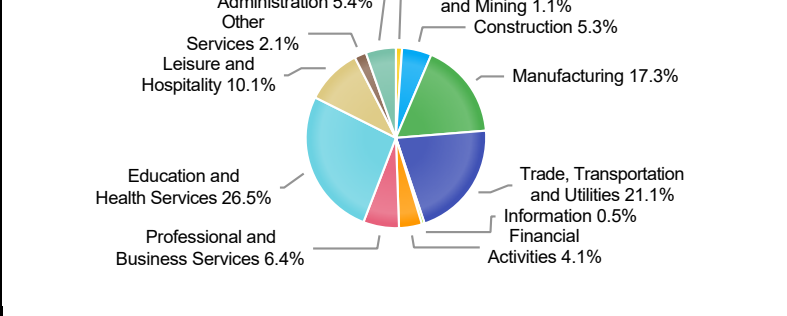
